**A RESOLUTION APPROVING THE CANVASS OF THE 2025
HARRISVILLE CITY MUNICIPAL PRIMARY ELECTION**

WHEREAS, Harrisville City (hereafter referred to as the “City”) is a municipal corporation duly existing under the laws of the state of Utah;

WHEREAS, on August 12, 2025, the regular Municipal Primary Election was held;

WHEREAS, on August 26, 2025, the City Council convened as the Board of Canvassers, to canvass the returns of the said Municipal Primary Election;

WHEREAS, the City Council, during the canvass of the ballots, inspected the ballot results by precinct including any absentee ballots received by Election Day;

WHEREAS, the City Council has determined that the election and voting were conducted in compliance with the law,

NOW, THEREFORE, be it resolved by the City Council of Harrisville City as follows:

Section 1. The City Council, as the official Board of Canvassers, hereby accepts and approves the reports entitled “Election Summary Report” and “Statement of Votes Cast” for the 2025 Harrisville City Municipal Primary Election held August 12, 2025.

Section 5. This Resolution shall be effective immediately upon passage and adoption.
