
Easter Egg Hunt

HARRISVILLE CITY CLEANUP DAYS

After a lengthy discussion, both at the City Council Retreat* and again in the February 2025 City Council meeting*, the City Council decided to make the following changes to the cleanup days event.

- **Location:** The location of the event will be moved from the Harrisville Main Park to the new Public Works building located at 708 West 1750 North. Access to the facility is off 750 West. See map below for more details.
- **Schedule:** The days and times of the cleanup event were also changed. The date and times will now be as follows:

April 23-26, 2025

Wednesday - Friday | 6:30 am to 8:00 pm

Saturday | 8:00 am to 1:00 pm

- **Requirements:** The event will require proof of residency. This event is for Harrisville residents only. In the past, dumpsters were available to the residents for convenience in removing unwanted green waste, garbage, or debris. Due to large amounts of waste, including construction waste and appliances, being left

outside the dumpsters or placed within, the prior costs of the event have been around \$15,000. To reduce this cost and burden on taxpayers, the City Council decided to have a residency verification process for those utilizing the dumpsters.

- **Allowed:** The **ONLY** items accepted at the Spring Cleanup event will be Green Waste. There will be no garbage/debris items collected. Again, this is to help reduce the cost of the event. Any garbage/debris items can be taken to the Weber County Solid Waste Transfer Station directly.
